### Conformance Testing Terms and Conditions

THE MODBUS ORGANIZATION'S ACCEPTANCE OF YOUR ORDER FOR TESTING OF EQUIPMENT UNDER THE MODBUS TCP OR MODBUS SERIAL PROTOCOL IS EXPRESSLY CONDITIONED UPON YOU AGREEING TO THE FOLLOWING TERMS AND CONDITIONS. PLEASE REVIEW THE TERMS AND CONDITIONS CAREFULLY. IF YOU AGREE WITH THE TERMS AND CONDITIONS, PLEASE SIGN THIS ORDER FORM IN THE SPACE BELOW AND RETURN THE SIGNED COPY TO THE MODBUS ORGANIZATION, INC.

1. **PROCEDURE.** Once the Modbus Organization receives an executed copy of this order form, your order for testing of the equipment listed above (the "Equipment") under the Modbus / TCP Protocol is deemed to be accepted by the Modbus Organization. Accepted orders may not be cancelled without the prior written consent of the Modbus Organization. Once your order for testing services is accepted, you should arrange to have the Equipment delivered directly to the Conformance Test Laboratory, as instructed by the Modbus Organization.

When testing services are complete, you will be contacted so that you can arrange to have the Equipment returned to you. The cost of delivery and return of the Equipment is your responsibility. The Modbus Organization does not assume any responsibility for the Equipment and the risk of loss of or damage to the Equipment while in the custody of the Conformance Test Laboratory and while the Equipment is in transit remains with you.

2. **SERVICE FEES.** You agree to pay the Modbus Organization the applicable service fees for testing the Equipment. As long as the Equipment is received at the Conformance Test Laboratory within 30 days of the date set forth on this order form, the applicable service fees will be those set forth on this order form. If the Equipment is not received at the Conformance Test Laboratory within 30 days, the fees for testing the Equipment will be the Modbus Organization's then current fees for testing services, which fees are subject to change without notice.

3. **PAYMENT.** Services fees must be paid in U.S. dollars within 30 days of the date of invoice.

4. **TAXES AND OTHER CHARGES.** You will be responsible for any use, sales, excise or other tax, duty, fee or charge of any nature whatsoever imposed by any governmental authority on the transactions contemplated by this order form (other than taxes on the Modbus Organization's income). Service Fees do not include any such taxes. THE MODBUS ORGANIZATION AND MODBUS ORGANIZATION AUTHORIZED TEST LABORATORIES DISCLAIM ANY AND ALL WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH RESPECT TO THE TESTING SERVICES AND THE TEST RESULTS.

7. **LIMITATION OF LIABILITY.** IN NO EVENT SHALL THE MODBUS ORGANIZATION, ITS LICENSORS, OR ANY OF THEIR RESPECTIVE OFFICERS, DIRECTORS, SUBSIDIARIES, PARENTS OR AFFILIATES BE LIABLE TO YOU OR ANYONE CLAIMING THROUGH YOU, FOR ANY SPECIAL, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND OR FOR ANY DAMAGES WHATSOEVER RESULTING FROM RELIANCE ON THE TEST RESULTS.
